

## TERMS & CONDITIONS

### BRITISH SKI AND SNOWBOARD NATIONAL FOUNDATION #BACKINGBRITISHSNOWSPORT FUNDING CAMPAIGN, 2021

- By entering into this fundraising scheme, each participant consents to these Terms and Conditions.
- Participants must be over 18 years of age (donations may be made by parents, guardians or responsible adults for rewards for under-18s).
- Rewards are open to anyone worldwide except for employees of the Promoters, their families, agents or anyone professionally connected with the fundraising campaign.
- Donations, including donations to unlock rewards, will be accepted between 0800 9 July 2021 and 1700 13 August 2021.
- Rewards may have their own specific terms and conditions to which the winner(s) will be required to adhere and which may include but are not limited to health and safety declarations, proof of appropriate insurance, proof of age, proof of eligibility or other requirements which we consider necessary for or appropriate to the nature of the specific prizes.
