

NORDIC DISCIPLINE COMMITTEE CHAIR VACANCY

We need a new Chair of the GBS Nordic Discipline Committee (DC), as Christian Ewald has completed an extended term. The formal job description is below. The role will be of interest to anyone who supports British Nordic skiing. The Chair of the Committee is also able to be considered for one of the three GB Snowsport Board Director roles reserved for the representation of DCs, although this entails being nominated by the six DC Chairs and is not an automatic entitlement.

This role could be of interest to an established businessperson or organisational leader skilled in corporate governance and fiduciary responsibility. Equally it could be attractive to an emerging business leader who wishes to broaden their CV.

Alternatively, if you have technical skiing knowledge and enthusiasm for GB Nordic skiing and wish to extend the trajectory of success in British cross country skiing established over the last 15 years this would be a challenging and enjoyable role. To be considered as a candidate your application should be in place by **August 21st** if possible.
