## Definitions

“Acting Chair”	means the individual appointed by the Selection Panel Chair to oversee selection in their absence;
“APA”	means Athlete Performance Award;
“APA Matrix”	means the table of performance criteria against which an APA is considered for an award for each discipline;
“Appeal Panel”	means the Panel involved with the Appeal Process;
“Appeal Process”	means the process for appeals outlined within the Policy;
“Appellant”	means an Athlete making an appeal under the Appeal Process within the Policy;
“Athlete”	means any Athlete who is part of a GBS Team or a GBS Squad;
“Athlete Eligibility”	means the minimum individual requirement for an Athlete to be eligible to be selected;

## 1. Introduction

- 1.1. This document contains the GB Snowsport (GBS) Selection Policy for Paralympic World Class Programmes (WCP) for the 2024-2025 season (the “Policy”). The aim of the GBS selection process is to support a long-term Performance Pathway, the development of elite Athletes, and the delivery of programmes to produce consistent World Class performances, most notably at World Championships and Paralympic Games.
- 1.2. The Policy describes the process for selection of Athletes and Guides across Para Alpine, Para Snowboard and Para Nordic to be invited to join WCPs representing Great Britain at Continental Cup and World Cup level, and the APA Matrix for the 2024-2025 season. Selection will be made without bias or discrimination. The Policy must be read in conjunction with the relevant discipline specific Schedule. The Schedules provide further detailed information to assist Athletes, Guides and coaches in understanding relevant criteria likely to be used by Selectors.
- 1.3. The Policy and processes are agreed and overseen by the Senior Leadership Team of GBS, the National Governing Body for Olympic and Paralympic Snowsport in Great Britain. The Policy and processes are approved by the Board of GBS. The Selection Panel will be solely responsible for making recommendations to UK Sport for Athletes to join a World Class Programme and for potential APA support.
- 1.4. Specific selection policies and processes will be published for World Championships and Paralympic Games.
- 1.5. This document also describes an Appeal Process. Any appeal against a decision of the Selection Panel must follow strict procedures laid down in the Appeal Process. Adherence to the Appeal Process ensures that all appellants are treated equally. There is a financial charge for making an appeal in order to discourage frivolous appeals.
- 1.6. The Policy and/ or the Selection Criteria contained herein may be amended from time to time by GBS. Should revisions be made, a further version of the Policy will be published. Consequently, each Policy and Schedule will supersede all earlier versions and will be versioned and dated such that no earlier policies may be used or deemed relevant

### Aims

- 1.7. The purpose of the Policy is to:
  - 1.7.1. maximise GBS’s goal of increasing medal potential at World Championships and Paralympic Games; and
  - 1.7.2. to provide opportunities for the long-term development of Athletes who are, in the opinion of the Selection Panel, capable of being podium competitive at international events.

### Remit

- 1.8. The Selection Panel will carry out selection in respect of all WCP Teams and Major Events falling within the jurisdiction of the Para Snowsport Programmes of Para Alpine, Para Snowboard and Para Nordic.



- 1.9. The level of programme support offered to selected athletes will be dependent on performance level.
- 1.10. In addition, the Selection Panel will be responsible for selecting the World Championship teams and will make a recommendation to the British Paralympic Association for Athlete and Guide selection for the Paralympic Games. As noted in 1.4, individual policies will be published for selection for these major events. For the Paralympic Games, GBS will agree and publish the Selection Criteria and Selection Procedures in co-operation with the British Paralympic Association (BPA).
- 1.11. For clarity, if an Athlete or Guide has not been selected onto the WCP they may still be eligible to attend training camps and competitions. This is described in the relevant Schedules as the 'Invitational' tier. This level of support is entirely at the discretion of the Head Coach and PD, and is not subject to the GBS Appeals Policy.

## **2. GBS WCP Selection Process**

- 2.1. The Selection Panel is responsible for the implementation of the Policy.
- 2.2. Membership of the Panel for selection relating to a specific discipline shall be as follows:
  - the Performance Director, or any other person nominated by the Board, who shall serve as chair
  - the Head Coach
  - an independent person with a legal background, who shall be nominated by the Company's Nominations Committee to serve for a twelve-month period
  - the Head of Paralympic Programmes; and
  - the relevant Discipline Coach
- 2.3. The panel may invite others to join the meetings
- 2.4. If any Panel member or meeting attendee declares an interest in a matter to be discussed then they may participate in the deliberations but must abstain from any vote and will not count towards the quorum
- 2.5. The quorum necessary for the transaction of business relating to each discipline shall be three members, one of whom must be the independent legal person (unless conflicted under 2.4 above) and another is to be either the PD (or any other person nominated by the Board to chair the Panel) or the Head Coach. Decisions of the Panel are taken by a simple majority vote without taking abstentions into account; in the event of a tie the chair of the meeting has the casting vote.
- 2.6. Selections will be made without bias or discrimination, and, as such, any conflicts, real or perceived, must be declared and recorded at the start of the meeting. The existence of a disclosed conflict will not preclude a Selection Panel member, or attendee, from participating in deliberations. Depending on the nature of the conflict, a Selection Panel member may have to abstain from voting if a vote is required.





- 2.7. The Selection Panel has total discretion to make selections appropriate to the event, championship, series, or programme, in accordance with the purpose of the Policy stated above. The Selection Panel will use, in conjunction with their own assessment, the most recent published discipline specific selection criteria as a guide to their deliberations and conclusions. Any appeal against a decision of the Selection Panel cannot challenge the exercise of discretion unless the appeal can demonstrate that the discretion has been exercised in a biased and/ or conflicted manner that is prejudicial to the appellant Athlete.
- 2.8. There is a four-stage process and timeline that will be applied to select Athletes to the 2024-2025 WCP:
- Athlete Eligibility;
  - Achievement of a Minimum Performance Standard – demonstrable achievement of discipline Performance Criteria;
  - Evaluation of the Athlete’s suitability and performance trajectory for inclusion onto the WCP; and
  - Potential nomination for APA support at the appropriate level.
- 2.6 Following WCP selection, APA nominations will be considered and reviewed by the APA Nominations Committee comprised of CEO, PD and Head Coach as voting members. These will then be communicated to UK Sport for their approval.

### **3. Athlete Agreements**

- 3.1. Athletes applying for their FIS Para Race Licence, must sign the FIS Athlete Declaration.
- 3.2. Once this is returned to GBS and the FIS Para Race License is purchased, Athletes will also need to complete and sign the GB Snowsport Performance Athlete Agreement and GB Snowsport FIS Licence Code of Conduct. This Agreement sets out the Athlete’s obligations to GBS, and what the Athlete can expect in return for their commitment. Athletes cannot be selected to WCP without a signed Athlete Agreement.
- 3.3. Athletes will be asked to provide evidence of valid insurance to cover them throughout the season as a condition of confirmation and retention of their squad status.

### **4. Process and Timings**

- 4.1. WCP selections will be made between June and September of each year. Each WCP Athlete Year is from 1<sup>st</sup> October – 30<sup>th</sup> September.
- 4.2. The Selection Panel reserve the right to add Athletes to the WCP during the season following outstanding performances or remove Athletes from the WCP for lack of performance or progress.



- 4.3. The Selection Panel reserve the right to remove Athletes from the WCP if there is a breach of the signed GB Snowsport Performance Athlete Agreement or GB Snowsport FIS Licence Code of Conduct.
- 4.4. Selection minutes are not made public but are kept on record. Redacted versions are available to any Athlete or Guide wishing to appeal the selection process results (see Clause 7).

## **5. Guidelines for Retention of Athletes Affected by Performance Limiting Factors**

- 5.1. Clause 5 only applies to those Athletes on WCPs for the 2023-2024 season.
- 5.2. Athletes should expect to be removed from the WCP if they fail to comply with the Performance Criteria set out in their discipline specific performance criteria (see relevant Schedule).
- 5.3. However, the Selection Panel can choose to retain an Athlete with a documented performance limiting factor such as injury or illness or, where an Athlete requires a Guide, where that Guide has been affected by a performance limiting factor and the requirements in Clause 5.5 below are satisfied. For any avoidance of doubt, a Performance Limiting Injury/ Illness may be physical or psychological.

### **Injury or Illness**

- 5.4. Current Athletes who suffered a Performance Limiting Injury in the 2022-2023 and/or 2023-2024 WCP Season will be considered for retention onto the WCP for the 2024-2025 season if:
  - 5.4.1. the Selection Panel considers that, when fully fit (and in its assessment the Selection Panel shall take into consideration the seriousness of and time lost to injury/illness, including the relevant Performance Limiting Injury), the Athlete still merits membership of the WCP based on their ongoing realistic performance potential;
  - 5.4.2. the CMO considers that the Athlete has a positive prognosis which would indicate that they have a realistic prospect of returning to their previous performance level; and
  - 5.4.3. the Athlete is and has been fully compliant with their rehabilitation programme, as set and amended from time to time by GBS, and in the opinion of GBS has not, whether by an act or omission, intentionally or otherwise, jeopardised their own recovery to the performance levels specified above.

### **Visually Impaired Athletes**

- 5.5. Visually impaired Athletes currently on WCP who require a Guide to compete and who fail to meet the Performance/Retention Criteria will be considered to remain on the WCP



If:

- 5.5.1. the Guide has been affected by a Performance Limiting Injury that, in the opinion of the Selection Panel at its absolute discretion, significantly impacts upon the Athlete's ability to meet the Performance Criteria;
- 5.5.2. the discipline Coach considers that the Athlete still has realistic potential to win a medal at the 2026 Paralympic Games (Podium Athlete) or a medal at the 2030 Paralympic Games (Podium Potential Athlete);
- 5.5.3. where, in the opinion of the Selection Panel, the Guide does not demonstrate the ability to recover sufficiently from their Performance limiting injury, the discipline Coach and Athlete are able to identify suitable Guide alternatives, which are then subject to the approval of the Head Coach and PD at their absolute discretion.

## 6. General Conditions

### Eligibility Conditions

*Events not on the Milan/Cortina 2026 Paralympic Games medal event programme*

- 6.1. Athletes will not be considered for WCP membership for events that do not feature on the Milan/Cortina 2026 Paralympic Games medal programme. If there has been confirmation of an event for the 2030 Paralympic Games, WCP membership MAY be considered at the discretion of the Head Coach and the PD, but will only be considered at Podium Potential level.
- 6.2. Should the Milan/Cortina 2026 Paralympic Games medal programme be altered during the 2024-2025 season, membership of the WCP will be immediately reviewed. A WCP Athlete whose chosen event/classification does not subsequently feature on the Milan/Cortina 2026 Paralympic Games medal event programme will be considered in alternative available events and the PD and Head Coach (at their sole discretion) may choose to retain an Athlete at any level on the WCP if they believe that, notwithstanding that the event in which the Athlete had previously competed is no longer on the medal event programme, the Athlete has the potential to successfully transfer to another discipline and win a medal at the Paralympic Games. The transfer period will be time limited and subject to performance milestones, both in terms of ability to transfer and application of a new WCP level and potential associated APA. The details of this will be developed on a case by case basis, led by the PD and Head Coach. Should the Head Coach and PD not believe an Athlete has the potential to successfully transfer to another event and win a medal at the Paralympic Games, they will be removed from the WCP with immediate effect.

### General Competitiveness of Events

- 6.3. Throughout the last few Paralympic cycles, the event programme, relevant standards, and competitiveness of events is known to have fluctuated significantly throughout each cycle. Therefore, for an Athlete to be considered eligible for selection to the WCP, the Selection Panel must be satisfied in its absolute discretion that the current depth and competitiveness of an event (according to the data available on the date of the selection



meeting) is sufficient to predict the event's future competitiveness and likelihood that the event will remain on the medal event programme:

- 6.3.1. for Athletes being considered for places on Podium Programmes – Milan-Cortina 2026 Paralympic Games; and
  - 6.3.2. for Athletes being considered for places on Podium Potential Programmes – 2030 Paralympic Games.
- 6.4. In assessing an event's competitiveness at the Milan-Cortina 2026 and 2030 Paralympic Games, the Selection Panel may consider the following and any other factors they deem relevant:
- 6.4.1. current world ranking data and nation/ region representation;
  - 6.4.2. 'Age' of event (i.e., when it was added to the medal event programme for the Paralympic Games, and whether it has been previously removed);
  - 6.4.3. Event/class development history;
  - 6.4.4. Historical trends of similar events/classes and/or;
  - 6.4.5. GBS's understanding of the international landscape.

#### **Medical Eligibility**

- 6.5. For both current and non-current members of the WCP, the Programme (including, if required, a designated medical practitioner) must be satisfied of the medical diagnosis underpinning their classification (such a diagnosis being a 'Relevant Diagnosis') for them to be considered eligible for remaining on programme or, or selection to, the WCP and the following provisions shall apply in any assessment of a Relevant Diagnosis:
- 6.5.1. It shall be the responsibility of the Athlete to obtain and provide documentary evidence of a Relevant Diagnosis so as to show that the Athlete meets the requirement of the sport to have a FIS classification;
  - 6.5.2. the Athlete shall comply with all reasonable requests of the CMO (or designated medical representative) for further evidence of the Relevant Diagnosis; and
  - 6.5.3. all documentary evidence submitted in support of a Relevant Diagnosis must be in English, dated, and signed by a registered medical professional who provided the diagnosis.
- 6.6. GBS is committed to best supporting the mental and physical wellbeing of their Athletes. For an Athlete to be selected they must be medically sound to meet the demands of the programme. This will be established via the medical screening and medical history conversation with the CMO. If an Athlete is found to have omitted critical medical information that would impact their health and wellbeing (both short and long term), put themselves or others at risk, or have an undisclosed injury/illness that would negatively impact performance, they will be asked to meet with the CMO, PD and any other relevant staff member to ensure that membership of the WCP is in their best interests.



### **Classification Reviews**

- 6.7. WCP membership status of any Athlete on the programme without a permanent classification will be considered upon review of their classification by an FIS International Classification Panel. In particular:
- 6.7.1. any Athlete who ceases to satisfy the eligibility requirements in Clause 6.5 following a review by an FIS International Classification Panel will be removed from the WCP with immediate effect;
  - 6.7.2. the funding level of any Athlete whose classification is changed will be subject to immediate review by the Head Coach and PD based on the Performance Matrix and Performance Criteria. Such an Athlete may then be subject to a change in their WCP programme level, or possible removal from the WCP, at the absolute discretion of the Head Coach and PD; and
  - 6.7.3. where the above paragraph applies, the Athlete continues to satisfy the FIS eligibility criteria, the Athlete will be automatically considered in alternative events assessed against the Performance Criteria as appropriate. The PD and Head Coach have absolute discretion over whether to retain/ select the affected Athlete at any level of the WCP.

## **7. Appeals Process**

- 7.1. Any Appeal against a decision of the Selection Panel must follow strict procedures. The following procedure is applicable to all Paralympic disciplines in respect of Selection.

### **Grounds of Appeal**

- 7.2. An Athlete, Guide or their Authorised Representative (the “Appellant”), may make an appeal against a selection decision only on grounds that:
- 7.2.1. There has been a failure to apply the criteria contained in the relevant Schedule correctly;
  - 7.2.2. the Selection Panel has failed to follow its procedures properly; or
  - 7.2.3. the Selection Panel’s discretion has not been exercised in a reasonable manner and that such discretion was exercised in such a way as to be prejudicial to the Appellant
- 7.3. The Appellant may only appeal against their own selection decision; they cannot appeal the selection decision of another athlete or guide under any circumstances

### **The Process**

- 7.4. In the first instance an Appeal is made to the Selection Panel, who will consider the Appeal and respond, either:
- 7.4.1. Agreeing with the Appellant and changing the original decision, or
  - 7.4.2. Rejecting the Appellant’s appeal and explaining its reasons for the decision



- 7.5. If an Appellant is not satisfied with the outcome of the Selection Panel's further deliberations, then the Appellant may make a further Appeal ("the Second Appeal Notice") to a different panel, the Appeal Panel ("the Appeal Panel"), based on the same grounds of Appeal and Appeal Notice.
- 7.6. Outcomes available to the Appeal Panel are:
- 7.6.1. To confirm the original Selection decision under Appeal will stand and reject the Appeal; or
  - 7.6.2. to refer the Selection decision under Appeal back to the Selection Panel, identifying any errors they have made in their deliberations or process (as per the grounds outlined in Clause 7.2) and requesting a new decision is made, or the original decision is confirmed, correcting any errors made by the Selection Panel, within a timeframe which allows their conclusions to be implemented.

### **How to Appeal**

- 7.7. An Appeal Process is commenced by an Appellant addressing an email to the Chair of the Selection Panel appealing against a decision made by the Selection Panel that resulted in the athlete or guide not being selected ("Notice of Appeal"). The email should be sent to [appeals@gbsnowsport.com](mailto:appeals@gbsnowsport.com). The email must be received by GBS within 24 hours of the notification of the Selection decision.
- 7.8. The Notice of Appeal must clearly set out the details of the decision which is being appealed and include full details of the Appellant's ground(s) of Appeal. The Notice should attach any documents or written evidence relevant to the grounds of Appeal and which are relied upon by the Appellant.
- 7.9. All Appeals must be accompanied by a bank transfer of £250 which will be refunded should the Appeal be upheld under Clause 7.4
- 7.10. Following the Appellant being informed of the outcome of the Selection Panel's further deliberations under Clause 7.4, the Appellant can raise a Second Appeal Notice if they do not agree with the outcome. The Second Appeal Notice is reviewed by an independent Appeals Panel, as outlined in Clause 7.12. The Second Appeal Notice must be made via email to [appeals@gbsnowsport.com](mailto:appeals@gbsnowsport.com) and be received by GBS within 2 hours of the Appellant being informed of the Selection Panel's decision under Clause 7.4
- 7.11. In the event of an Appeal, minutes of the Selection Panel's Selection decisions or of any Appeal hearing will be made available to the Appellant upon request and will be provided as soon as is reasonably possible. In some cases, it may be necessary to redact elements of the relevant minutes.

### **The Appeal Panel**

- 7.12. GBS will nominate an Appeal Panel of at least 3 members, none of whom sat on the Selection Panel, none of whom are conflicted, and one of whom is Independent. One of the members of the Appeal Panel shall have a legal background. The members will



select a Chair of the Appeal Panel.

- 7.13. The Appeal Panel must receive the Second Appeal Notice as per Clause 7.5 and within the timeframes outlined in Clause 7.10. The only fee required is when the Appellant first makes an Appeal to the Selection Panel. A second fee is not required if the Appeal reaches the Appeal Panel.
- 7.14. The Chair of the Appeal Panel will convene a meeting to take place within a timeframe which allows the decision of the Second Appeal Notice to be reviewed and appraised by the Appeal Panel.
- 7.15. The Appeal Panel will investigate the grounds of Appeal set out in the Second Appeal Notice and establish, to their reasonable satisfaction, which of the outcomes set out in Clause 7.6 is most appropriate. The Chair of the Appeal Panel will notify the Selection Panel Chair and the Appellant, of their decision immediately after the meeting.
- 7.16. The decision of the Appeal Panel, and if required, subsequent review by the Selection Panel, following the Second Appeal Notice is final. No further Appeal of the same initial grounds of Appeal will be considered.



## Schedule A: APAs and Paralympic Programme Selection

### Overview

- A 1.1. This Schedule describes the UK Sport Athlete Performance Award (APA) Policy and selection onto a UK Sport funded World Class Programme (WCP) and how this will be applied to the GB Snowsport Paralympic disciplines.
- A 1.2. The GBS APA Nominations Committee nominate Athletes against a particular APA band based on the achievement and performance trajectory of each Athlete. It is at UKS's discretion to accept or reject any nomination.
- A 1.3. For avoidance of any doubt, APA awards from A-E are reflective of the Performance Standard required to be accepted onto WCPs. There may be individual cases whereby an Athlete is nominated onto WCPs but is not in receipt of an APA.
- A 1.4. UKS has granted GBS a maximum number of APA places across the Paralympic disciplines. The GBS Nominations Committee will consider Athlete nominations for these places and it is at the discretion of GBS to nominate the places across disciplines; no nominations are ring-fenced to a particular discipline. GBS are not obliged to fill every APA space. All eligible Athletes, meeting the required performance standard will be considered by the Selection Panel and nominations will be sent to UKS for approval.

THE BELOW AREAS IN ITALICS, HAVE BEEN TAKEN FROM THE UK SPORT ATHLETE PERFORMANCE AWARD POLICY FRAMEWORK (Version: November 2021)

### **UKS 1. Policy Framework – Overview**

*UKS 1.1 Podium APAs are designed to support athletes whose profile indicates a strong prospect of achieving/contributing<sup>2</sup> to medal winning performances at the Olympic or Paralympic Games within the cycle and who are already achieving/contributing to international results within the medal zone*

- Podium awards are made at A and B levels
- An additional award level 'Milan-Cortina Potential' is provided to support athletes that have been in receipt of a Podium level award, do not meet the competition outcome standards to retain an A or B award, yet remain a strong medal prospect for Milan-Cortina.

*UKS 1.2 Podium Potential APAs are designed to support athletes who have been identified and confirmed as having the potential to bridge the gap to Olympic and Paralympic medal success and have made the commitment to pursue this goal*

- Podium Potential awards are made at C and D levels.

*UKS 1.3 Entry Level APAs are designed to support athletes in their first 1-2 years of inclusion in high-performance programmes, to provide a period through which the potential of the athlete is explored and confirmed.*

### **UKS 2. Policy Framework – Criteria and Standards**

*The specific criteria against which athletes are selected at each award level will be defined on a sport specific basis drawing on the performance requirements and pathway standards set out in the Performance Matrix. Criteria should be forward looking, objective or able to be assessed robustly, and underpinned by evidence of why they are being used as a basis for selection.*





*Within this selection criteria, UK Sport will expect to see a stated competition outcome standard at A, B, C and D levels. To ensure parity of the standards and expectations at each award level the following descriptions, benchmarks, and policies should be applied when forming sport specific selection criteria:*

### **UKS 2.1 At Podium A level:**

- a) Athletes will have made the commitment to target a medal in Milan-Cortina and be considered capable of sustaining or improving on current performance levels. They will have the knowledge and experience to sustain a healthy high-performance lifestyle, and to achieve consistent performance in targeted events*
- b) Athletes will have achieved/contributed to i) a medal winning performance at the Olympic Games, ii) a gold medal winning performance at the Paralympic Games or iii) achieved/contributed to the equivalent performance at a senior world championships (where the competitive level in the world championships is comparable to those at the Olympic or Paralympic Games)*
- c) Where a senior world championship takes place in a Games year, performances in this event will not be considered as a benchmark for an A level APA*
- d) In a year where no senior world championship takes place, a sport can nominate an alternative event, where evidence can be provided that the event, and the stated performance outcome in the event, are of an equivalent standard*
- e) To be eligible to receive the A+ level APA, athletes must have achieved more than one performance at this level. The two A level performances must be achieved in different competitive seasons with at least one of these performances having been achieved in the senior world championship or Olympic/Paralympic Games*
- f) Olympic medallists and Paralympic gold medallists can, in principle, remain eligible to receive an A and A+ level APA for up to a maximum of four years (the equivalent of the Milan-Cortina Olympic/Paralympic Cycle), provided they remain on track to achieve/contribute to a medal winning performance in Milan-Cortina*
- g) Athletes receiving an A and A+ level APA that has been triggered through performance at a senior world championships can, in principle, remain eligible to receive an APA at this level for two years provided they remain on track to achieve/contribute to a medal winning performance in Milan-Cortina.*

### **UKS 2.2 At Podium B level:**

- a) Athletes will be considered capable of targeting medal success in Milan-Cortina and will have made the commitment to do so. By this stage athletes will be expected to have the knowledge and experience to sustain a healthy high-performance lifestyle and to deal with pressures of performing in major international competition*
- b) As a minimum, Olympic athletes will have achieved a top 8 individual or have contributed to a top 6 team finish at the Olympic Games or senior world championships, with Paralympic standards expected to reflect a medal (silver or bronze) performance*
- c) Where a senior world championship takes place in a Games year, performances in this event will only be considered as a benchmark for a B level APA in exceptional circumstances*
- d) In a year where no senior world championship takes place, a sport can nominate an alternative event, where evidence can be provided that the event, and the performance expectation in the event, are of an equivalent standard*
- e) To be eligible to receive the B+ level APA, athletes must have achieved more than one performance at this level. The two B level performances must be achieved in different competitive seasons with at least one of these performances having been achieved in the world championship or Olympic/Paralympic Games*



*f) Athletes receiving a B and B+ level award can, in principle, remain eligible to receive an award at this level for two years provided they remain on track to achieve/contribute to a medal winning performance in Milan-Cortina.*

### **UKS 2.3 At Milan-Cortina Potential level:**

- a) Athletes will only be considered at this level where they have previously been in receipt of a Podium A or B level award and there are exceptional circumstances that have prevented them retaining an award at that level*
- b) Despite not meeting the competition outcome standard to remain at A or B level, there will be strong evidence that the athlete is capable of bridging the gap to medal success in Milan-Cortina and has made the commitment to do so*
- c) Milan-Cortina Potential awards are made for no more than one year.*

### **UKS 2.4 At Podium Potential level:**

- a) C level athletes will be competing internationally and have met the stated performance outcome in competition and in other defined performance requirements that indicate their potential to graduate to Podium level and go on to achieve medal success*
- b) D level athletes will have been through a period of confirmation, will have made the commitment to pursue Olympic or Paralympic medal success and have met the standards against performance requirements that indicate their potential to graduate to Podium level and go on to achieve medal success*
- c) Standards set at C and D level should reflect what it will take to graduate to Podium level within a given timeframe. Guidance on this timeframe should be set out in athlete selection policies to manage expectations and provide a trigger for the review of an athlete's progress*
- d) Athletes who have previously received an award at Podium level will not be considered eligible for Podium Potential awards except where the athlete has chosen to pursue success in a different sport or event/discipline.*

### **UKS 2.5 At Entry level:**

- a) Athletes will have been identified as having the attributes to pursue success in the Olympic or Paralympic Games and have committed to engage in a trial period*
- b) Entry level awards will be offered for no more than two years*
- c) Athletes who have previously received an APA at D level or above will not be eligible for an Entry level award except where the athlete has chosen to pursue success in a different sport or event/discipline.*

### **UKS 2.6 Team and Relay APA Performance Standards:**

- a) Whilst the standards above are designed to relate to both individuals and teams, UK Sport acknowledge that it may not be appropriate to provide all members of a team or relay with the same level of APA. In preparing the selection policy for teams and relays, consideration should be given to the performance record and/or contribution of individual team members*
- b) Other factors such as commitment to team training, regular selection to a team and performance at milestone or other significant events, may also be used as a determining factor in the APA level offered.*



#### **UKS 4. Injury and Illness:**

4.1 In the event of injury/illness (both physical and mental), and in cases where an athlete is considered likely to recover to full fitness for training and competition, the athlete will continue to receive their full APA up to three months from the point the injury/illness occurred or was identified.

4.2 If after three months the athlete remains unavailable for full selection or training, an expert review will be undertaken to confirm the likelihood that the athlete remains able to pursue success in the Olympic/Paralympic Games, to agree a programme of rehabilitation and to plot a timetable for return to full training and competition.

4.3 Each case will be considered on its own merit, and further expert advice may be sought where the long-term impact of the injury/illness is unclear (such as referral to the mental health panel). The athlete's progress against the timetable will need to be reported to UK Sport every three months thereafter, until the athlete has either fully resumed training and competition or left the programme.

4.4 Subject to satisfactory evidence of the likelihood of return, the APA will continue to be paid at the existing award level for up to a year but will only be extended beyond this in exceptional circumstances.

4.5 Where there is medical evidence that the injury/illness will affect the long-term potential of the athlete, or where the athlete has shown neither progress nor commitment to the agreed rehabilitation programme, the athlete can be removed from APA support providing an appropriate period of notice is given – see Athletes Leaving the Programme.

#### **UKS 5. Pregnancy**

Being pregnant and an elite athlete should not be mutually exclusive. To ensure support is provided for athletes who wish to have a child whilst they are in membership of a high-performance programme and in receipt of an APA, the following policy will apply:

5.1 Athletes in receipt of APA funding will remain eligible to access their full APA (subject to means testing) for the duration of the pregnancy at the APA level they were on at the time of becoming pregnant and for up to nine months post childbirth.

5.2 Continued access to the APA post childbirth will be dependent on:

a) The athlete's intention to return to the sport and the programme being discussed and confirmed no later than six months post childbirth

b) At the point where the intention of the athlete is clear, forming a mutually agreed plan/timetable for return to training and competition – this plan should acknowledge the athlete's experience of pregnancy, the impact on them physically and mentally and the nature of the event they are returning to

c) Monitoring, reviewing and confirming that the athlete has made the necessary commitment to this plan and is on track to return.

5.3 If the level of commitment and or progress against this plan are not demonstrated, the athlete would be given notice and offered a period of transition before the APA funding stops (see Athletes Leaving the Programme).

5.4 At nine months post childbirth the potential of the athlete will be assessed and confirmed to UK Sport in order to continue to access the APA. It is important to note that this assessment should indicate the athlete's future medal potential and not necessarily performance outcomes.

5.5 An athlete who announces retirement from their sport during pregnancy or in the initial six months post childbirth, will not be given a further period of notice before the APA terminates.

5.6 In the event of complications either during the pregnancy or post childbirth, this policy will be flexed as is reasonable to accommodate these circumstances on a case by case basis.



## **UKS 6. APA Funding During Athlete Transition:**

### *Athletes Joining the Programme*

6.1 All athletes will participate in a comprehensive induction process when joining the high-performance programme or when changing between levels of the Performance Pathway. Where athletes are new members of the programme and are receiving an APA for the first time, GBS will ensure the athlete(s) are provided with sufficient support and opportunity to effectively transition into the programme.

### *Transitions within Teams/Partnerships*

6.2 Where an athlete is in receipt of a Podium level APA and is adversely impacted by the retirement of a partner or team member(s) a period of transitional APA funding can be agreed before an objective performance assessment of the newly formed team takes place. In these cases, the APA can be sustained at the current level (or at the Milan-Cortina Potential level) for up to two years.

### *Transitions between Events/Disciplines*

6.3 Where an athlete is in receipt of a Podium level APA and transitions to a new event or discipline within their sport, a period of transitional APA funding can be agreed before the athlete is expected to meet the performance criteria within the new event or discipline. In these cases, the APA can be sustained at the current level (or at the Milan-Cortina Potential level) for up to two years.

### *Transitions between Sports*

6.4 Where an athlete is attempting to transfer between two sports, and is currently in receipt of an A, B, C, or Milan-Cortina Potential APA, the athlete can be nominated for a transitional APA up to two years before being expected to meet the APA selection standards in the new sport.

6.5 The APA can be extended beyond 12 months where circumstances prevent an athlete achieving a result or performance, which could include:

- a) Injury, illness or pregnancy (see above)
- b) External factors such as cancelled competition opportunities
- c) The sport's schedule for athlete selection not aligning to this timescale.

6.6 Athletes in receipt of an A level APA will receive a maximum award of A (£26,500 p.a.) and athletes in receipt of a B level APA will receive a maximum award of B (£21,500 p.a.) during this transitional period.

### *Athletes Leaving the Programme*

6.7 GBS are committed to support athletes health and welfare when leaving the programme.

6.8 A minimum of a one-month notice period will be provided to all athletes that are no longer nominated at Podium or Podium Potential level or will receive a reduction in APA funding as a consequence of the level at which they have been nominated.

6.9 This period of notice will be within an athlete's current award term, i.e. athlete reviews should be conducted before APAs are due to expire to allow for this notice period and paperwork to be turned around.

6.10 Additional transitional funding will be offered at the current grant level for a period of time dependent on the total continuous period of programme membership. This additional transitional funding will be provided as follows:



*>1 year but <2 years = 1 month transitional award*

*>2 years but < 3 years = 2 month transitional award*

*>3 years = 3 months transitional award*

*6.11 Where appropriate, programmes will continue to provide access to essential services and support during the transitional period and specifically to medical services where there is necessary to support the treatment of a pre-existing medical condition.*

*6.12 Whilst sports are asked to accommodate as much of the transitional award period as possible within the current award term, new athletes can be nominated before the transitional award period ends.*

*6.13 Once an athlete leaves the programme, they will no longer receive access to medical cover through AMS. However, AMS cover will continue for up to a maximum three months after the month their funding ceases for an existing medical claim and treatment to finish. No new claims can be opened within this three-month extension period.*

*6.14 Where an athlete is leaving the programme for disciplinary reasons, or due to a lack of engagement in the programme, the NGB and UK Sport in consultation, have the discretion to revoke any transitional funding.*



## **GBS APA Nomination Process**

- A 2.1. The GBS APA Nominations Committee, which is a committee of the Selection Panel, will consider all Athletes and Guides meeting the APA Performance Criteria.
- A 2.2. The APA Nominations Committee will review the list of athletes meeting the criteria. The APA Nominations Committee has complete discretion when nominating athletes to UK Sport for APAs and will consider the following criteria:
  - 2.2.1. Attainment of performance criteria outlined in the discipline specific Schedules
  - 2.2.2. That an Athlete is on an upwards performance trajectory
  - 2.2.3. That an Athlete must demonstrate continued progression to podium; and
  - 2.2.4. Results achieved in the 12 months prior to the APA being awarded
- A 2.3. There is no Paralympic APA Ringfencing; i.e., no set amount of APA's for Para Alpine, Para Snowboard or Para Nordic
- A 2.4. Podium APAs will take precedence; once these are filled, C Band Athletes will be reviewed, followed by D Band and finally E Level
- A 2.5. For the avoidance of doubt, attainment of the APA Performance Criteria does not imply Selection to the WCP, or that an APA will be awarded
- A 2.6. In the case of injury/ illness preventing an athlete from competing at a milestone target event, discretion can be applied and reference made to the athlete's results pre-injury
- A 2.7. The APA Nominations Committee retains the ability to nominate an athlete for an APA with conditions attached.
- A 2.8. Should there be more Athletes achieving APA standards than there are places available, it is at the discretion of the Selection Panel, the Head Coach and the PD to select Athletes onto WCPs without an APA nomination.



## Schedule B: GBS - Para Snowboard WCP Selection Eligibility Criteria

### GBS: Para Snowboard WCP Selection

- B 1.1 GBS's approach to selection is to best support a long-term Performance Pathway, the development of elite Athletes, and the delivery of programmes to produce consistent World Class performances, most notably at World Championships and Paralympic Games
- B 1.2 For Athletes to be considered for the GBS Paralympic WCP, they must demonstrate a progressive performance profile aligned to targets for the season and subsequent cycle. As WITTW models are developed, clear performance targets for squad selection will be identified and communicated.
- B 1.3 Athletes must show commitment to a training and competition programme agreed with the Para Snowboard WCP Coaches, Head Coach and PD which supports individual performance goals and outcomes. Failure to do so may result in removal from the WCP.

### Athlete Eligibility

- B 2.1 Athletes must:
  - B 2.1.1 be eligible to compete for ParalympicsGB at the Paralympic Games (i.e., are a British National and hold a valid passport for the United Kingdom of Great Britain and Northern Ireland);
  - B 2.1.2 be WADA compliant and not be banned or suspended from competition due to an Anti-Doping Rule violation (ADRV) ruling or Investigation
  - B 2.1.3 hold a valid FIS Para Snowboard Licence for the 2024-2025 season;
  - B 2.1.4 be born in 2009 or earlier;
  - B 2.1.5 be internationally classified with a sport class status of "Confirmed" or "Review 2025 or later"; athletes with an alternative "Review" sport class status, such as "Review 2024", may be eligible for selection, but conditions may be applied. This will be on a case-by-case basis and at the discretion of the Head Coach and PD;
  - B 2.1.6 not, whether by act or omission, have brought GBS into disrepute.
  - B 2.1.7 be compliant with the [UKS Athlete Eligibility policy](#).
  - B 2.1.8 not have any outstanding financial obligations to GBS

### Performance Criteria

- B 3.1 GBS have aligned selection to WCPs and the APA Matrix. For further information on Athlete Performance Awards, please refer to Schedule A.



B 3.2 Clause B 3.5 outlines the Performance Standard required for selection onto the Para Snowboard WCP. For ease of reference, the table also includes the aligned APA level

B 3.3 For Athletes competing in both Banked Slalom and Snowboard Cross, the performance attainment in their highest ranked discipline will be used for Programme selection and any subsequent APA nomination. Whilst single results take precedence for selection, they will be reviewed in the context of the individual Athlete’s progression and wider result attainment across the previous season. Please note that results achieved in a Team Event will not be used to inform selection but may be used as supporting information.

B 3.4 Achieving the Performance Standard in Clause B 3.5 shall not automatically result in award of an APA; the process for allocation of APAs is outlined in Schedule A.

**B 3.5 Para Snowboard WCP:**

B 3.5.1 Podium APAs

Podium APAs are designed to support athletes whose profile indicates a strong prospect of achieving/contributing to medal winning performances at the Olympic or Paralympic Games within the cycle and who are already achieving/contributing to international results within the medal zone

- Podium awards are made at A and B levels
- An additional award level ‘Milan-Cortina Potential’ is provided to support athletes that have been in receipt of a Podium level award, do not meet the competition outcome standards to retain an A or B award, yet remain a strong medal prospect for Milan-Cortina.

### Athlete Suitability for Programme Inclusion

B 4.1 GBS's approach to selection is to best support athletes with medal potential for this Paralympic Games or the next.

B 4.2 In addition to the Performance Standards outlined in Clause B 3.5, the Selection Panel will consider a range of factors when selecting athletes, these include the following (in no priority order):

B 4.2.1 Athlete's current form and recent results achieved at FIS Para Snowboard World Cup events in the 2023-2024 season

B 4.2.2 The Athlete's major competition history (including World Cups, World Championships and Paralympic Games)

B 4.2.3 The Athlete's full commitment to their training and competition programme including any S&C training, as agreed with their Coach and the Head Coach and PD

- B 4.3 The Selection Panel has absolute discretion to select the athletes who in their reasonable opinion are most likely to achieve medal winning performances at this Paralympic Games or the next

  - C 2.1.3 hold a valid FIS Para Alpine License for the 2024-2025 season;
  - C 2.1.4 be born in 2008 or earlier;
  - C 2.1.5 be internationally classified with a sport class status of "Confirmed" or "Review 2025" or later"; athletes with an alternative "Review" sport class status, such as "Review 2024", may be eligible for selection, but conditions may be applied. This will be on a case-by-case basis and at the discretion of the Head Coach and PD;
  - C 2.1.6 not, whether by act or omission, have brought GB Snowsport into disrepute.
  - C 2.1.7 be compliant with the [UKS Athlete Eligibility policy](#).
  - C 2.1.8 not have any outstanding financial obligations to GBS

### Performance Criteria

- C 3.1 GBS have aligned selection to WCPs and the APA Matrix. For further information on Athlete Personal Awards, please refer to Schedule A.
- C 3.2 Clause C 3.5 outlines the Performance Standard required for selection onto the Para Alpine WCP. For ease of reference, the table also includes the aligned APA level



C 3.3 For Athletes competing across multiple events within the technical and speed disciplines, the performance attainment in their highest ranked event will be used for Programme selection and any subsequent APA nomination. Whilst single results take precedence for selection, they will be reviewed in the context of the individual Athlete's progression and wider result attainment across the previous season. Please note that results achieved in a Team Event will not be used to inform selection but may be used as supporting information.

### Calculation of Baseline & Milan-Cortina Cycle Para Alpine Baselines

- C 4.1 An Athlete's FIS Points in any given race are given a direct reflection of their performance in that race and as such are a proxy for their time behind the winning Athlete. The FIS Points can therefore be used to accurately show how far, as a percentage, an Athlete is behind the best in the World.
- C 4.2 The Alpine Skiing Baselines are calculated by averaging the FIS Points of the top 5 Athletes on the yearly end of season Points List and then averaging this with the Baseline from the previous season. By including the previous season's figure, we are able to ensure that historical performances are always factored into the Baseline but with the



weighting for previous seasons reducing by 50% each year. The average of the previous four seasons baselines is then used as the overall baseline.

C4.3 FIS changed the Para Alpine Skiing F-Values for all disciplines at the start of the 2023-2024 season. The Baselines for the 2024-2025 season and beyond have been recalculated using the updated F-Values to adjust for the changes.

<b>Podium B</b> <b>£21,500 p.a.</b>	Athletes who have achieved a SILVER OR BRONZE medal at a Milestone Event AND are considered by the Selection Panel to retain realistic medal potential for the 2025 World Championships and/or the 2026 Paralympic Games

**E 3.5.2 Podium Potential APAs**

Podium Potential APAs are designed to support athletes who have been identified and confirmed as having the potential to bridge the gap to Olympic and Paralympic medal success and have made the commitment to pursue this goal

<b>Podium Potential C</b> £16,000 p.a.	Two results in the previous 12 months at a FIS Para Nordic World Cup, FIS World Championships or Paralympic Winter Games, that are within 5% of 3rd place (priority will be given to athletes with results in multiple race disciplines)
<b>Podium Potential D</b> £12,500 p.a.	Two results in the previous 12 months at a FIS Para Nordic World Cup, FIS World Championships or Paralympic Winter Games, that are within 10% of 3rd place (priority will be given to athletes with results in multiple race disciplines)

### E 3.5.3 Entry Level APAs

Entry Level APAs are designed to support athletes in their first 1-2 years of inclusion in high-performance programmes, to provide a period through which the potential of the athlete is explored and confirmed.

<b>Entry Level</b> £7,500 p.a.	Two podium results in the previous 12 months at a FIS Para Nordic Continental Cup, that are also within the top 50% of the field  OR  One single result in the previous 12 months at a FIS Para Nordic World Cup that is within 15% of 3 <sup>rd</sup> Place
<b>Invitational</b>	Inclusion in World Class Programmes (and potential Entry Level APA support) will be considered on a case by case basis for those Athletes deemed to have medal potential within 4 years, but who have not yet achieved the performance standard required. Invitational programme inclusion can be offered for a maximum of 1 year. Selection is at the complete discretion of the Head Coach and PD and is not subject to the Appeals Policy

### Athlete Suitability for Programme Inclusion

E 4.1 GBS's approach to selection is to best support athletes with medal potential for this Paralympic Games or the next.

E 4.2 In addition to the Performance Standards outlined in Clause E 3.5, the Selection Panel will consider a range of factors when selecting athletes, these include the following (in no priority order):

E 4.2.1 Athlete's current form and recent results achieved at FIS Para Nordic World Cup events in the 2023-2024 season





- E 4.2.2 The Athlete's major competition history (including World Cups, World Championships and Paralympic Games)
- E 4.2.3 The Athlete's full commitment to their training and competition programme including any S&C training, as agreed with their Coach and the Head Coach and PD
- E 4.2.4 The Athlete meeting or exceeding all benchmarks set in their Individual Athlete Plan
- E 4.2.5 The Athlete's training history
- E 4.2.6 The Athlete's performance trajectory
- E 4.2.7 Race formats and quality/ depth of field where results have been achieved
- E 4.2.8 Medal potential for the 2026 and/ or 2030 Paralympic Games
- E 4.2.9 Athlete's contribution to the creation of a World Class performance culture
- E 4.3 The Selection Panel has absolute discretion to select the athletes who in their reasonable opinion are most likely to achieve medal winning performances at this Paralympic Games or the next
- E 4.4 For existing WCP Athletes, in addition to all conditions outlined above, Athletes must:
  - E 4.4.1 Have met last year's performance targets; and
  - E 4.4.2 Have, at a minimum, maintained their level of performance from the previous year. Failure to do so may result in Athletes not being selected.
- E 4.5 In extraordinary circumstances the Selection Panel has absolute discretion to consider (and give additional weight to) any other factors they deem relevant in respect of their selection decisions including (but not limited to) training data, progress against individual performance plan and technical development. These factors will be taken in the context of the likelihood of the athlete being able to produce consistent World Class performances, most notably at World Championships and Paralympic Games in accordance with the aims of the Policy.
